- Who should pay for historic contamination?
- Legal when it occurred
- Polluter pays
- Who's the polluter?

Corporations can do harm

- Giant Mine, need I say more?
 - bad regulation, weak science, shortterm thinking, profits now...
- So can governments, individuals, wars...
- Is limited liability part of why?
 - Shareholders v directors...

Corporate veil eroding

- Personal liability for officers / directors for what they could have prevented
- NWT EPA 14.1. (1) Where a corporation commits an offence under this Act or the regulations, any officer, director or agent of the corporation who directed, authorized, assented to, acquiesced in or participated in the commission of the offence is a party to and is guilty of the offence

But

- Is unlimited personal, retroactive, no-fault liability just and fair?
- If so, for who?
 - shareholders?
 - employees?
 - lawyers /engineers?
 - directors?

Ontario likes it

- Escheats
- Prosecutions
- Orders

Escheats Proposal

- Any director in corp's last 2 years
- All legacy costs
- Can directors resign?
 - Race to resign?
 - New roles for the homeless

Prosecutions

- Outside s. 194 (reasonable care)
- Respondeat superior?
- Vicarious liability?
- Who's a "director" or "officer"?

Orders

- Infinite, permanent, personal, retroactive, no fault liability?
- Baker v Director
 - Director of US based parent
 - Only during \$20 M cleanup
 - Historic TCE

Baker cont.

- Govt changed standards
- Issued \$10 M FA order
- Northstar to CCAA
- MOE failed to get \$ from creditor

Baker order

- Est. \$15 million order to Baker etc.
- Shaw asst corp secretary
 - did firm get fees?
- No fault
- No cap, no expiry
- Joint and several

Baker appeal

- Order appealed: unconstitutional, no jurisdiction, unfair
- Basis of liability unclear
 - particulars motion
- No stay pending appeal
- \$150K/ month

Consequences?

- Who wants to be a director?
 - charities too
- Social, economic, environmental?
- Institute of Corporate Directors
- Just and fair?
