

**NOTICE OF DISCONTINUANCE OF CANADIAN ZOFRAN CLASS ACTIONS –
FOR WOMEN WHO USED ZOFRAN DURING PREGNANCY AND THEIR CHILDREN**

Please Read This Notice Carefully. It May Affect Your Legal Rights.

TO all persons in Canada who ingested Zofran and/or generic ondansetron hydrochloride (hereafter “Zofran”) during the first trimester of pregnancy and experienced a third trimester miscarriage or still birth, AND TO all persons in Canada born with birth defects to women who ingested Zofran during the first trimester of pregnancy, AND TO all persons who can claim on behalf of such persons or whom are family members of such persons:

In 2015, Siskinds LLP and Siskinds Desmeules (hereinafter “**Siskinds**”) commenced proposed class proceedings in Ontario and Quebec concerning Zofran, a prescription medication approved for the prevention and treatment of nausea and vomiting associated with chemotherapy, radiotherapy, and surgeries. These actions alleged that Zofran was negligently manufactured, marketed, and sold to treat nausea and vomiting in pregnant women and without adequate warnings of the risks of such use. The defendants in the action deny these allegations.

Siskinds is of the opinion that the proposed Zofran class proceeding is no longer viable. On this basis, Siskinds filed motion materials with the Ontario Superior Court of Justice and the Superior Court of Quebec to obtain approval of the discontinuance of the class proceedings. The discontinuance was approved by the Courts and took effect on February 26, 2025, in Ontario and on July 31, 2025, in Quebec.

YOU SHOULD TAKE NOTICE THAT your limitation period for bringing a claim, if there is any time left within it, may be impacted by the discontinuance of the actions. On the expiry of a limitation period a right to sue may be extinguished.

TAKE NOTICE THAT because the limitation period for bringing a claim may be impacted by the discontinuance, if you wish to pursue a court claim arising from Zofran in relation to birth defects or pregnancy loss, you should immediately take steps to preserve your ability to do so. **Siskinds will answer questions about the discontinuance or the running of limitation periods.
