



1. **THIS COURT ORDERS** that the within proceeding is discontinued on a without costs and without prejudice basis as against:
 - (a) Samtel Color, Ltd.;
 - (b) Shenzhen SEG Hitachi Color Display Devices, Ltd.; and
 - (c) Irico Group Corporation, Irico Display Devices Co., Ltd and Irico Group Electronics Co., Ltd.
2. **THIS COURT ORDERS** that notice under sections 19 and 29 of the *Class Proceedings Act, 1992*, S.O. 1992, c.6 is not required.
3. **THIS COURT ORDERS** that the balance of the relief sought is adjourned *sine die*, to be heard either in writing with supplementary material or virtually on a date and time to be arranged through the trial coordinator. No more than 30 minutes should be required.
