ORDER

Certification and Notice Approval

UPON MOTION, made by the plaintiff for an order approving the notice of settlement approval hearing (“**Notice of Certification and Settlement Approval Hearing**”) and the plan of dissemination of that notice (the “**Notice Plan**”), and certifying this action as a class proceeding for settlement purposes only;

ON REVIEWING the materials filed on this motion, including the affidavit of Jennifer Bald sworn on December 12, 2025, and the affidavit of Christopher Makkreel sworn on December 11, 2025;

AND CONSIDERING the contents of the Notice of Certification and Settlement Approval Hearing and the Notice Plan;

AND CONSIDERING the settlement agreement dated November 17, 2025, attached to this Order as **Schedule “A”** (the **“Settlement Agreement”**);

AND HEARING the submissions of counsel for the parties by videoconference on December 17, 2025;

AND CONSIDERING the requirements for certification on consent and for notice in Rule 334 of the *Federal Courts Rules*;

AND UPON BEING ADVISED that the plaintiff and Settling Defendants (which are all of the defendants named in this action) consent to this Order;

THIS COURT ORDERS that:

1. For the purposes of this order, except to the extent that they are modified in this order, the definitions set out in the Settlement Agreement apply to and are incorporated into this order.
2. This action is certified as a class proceeding as against the Settling Defendants for settlement purposes only.
3. The Settlement Class is certified as follows:

All Persons in Canada who purchased Caustic Soda during the Class Period, except the Excluded Persons and any Opt-Out.

4. Topher's Beard Company is appointed as representative plaintiff for the Settlement Class.

5. The following claims are asserted on behalf of the Settlement Class:

(a) Claims for loss or damage arising from unlawful conspiracy, under s. 36 of the *Competition Act*.

6. The relief sought by the Settlement Class is:

(a) Damages in the amount of any unlawful overcharge.

7. The following issue is common to the Settlement Class:

Did the Settling Defendants conspire to fix, maintain, increase or control the price of Caustic Soda directly or indirectly during the Class Period?

8. Putative Settlement Class members may opt out of this Action by sending a written request to opt out to Class Counsel on or before the Opt-Out Deadline. The written election to opt out must be signed by the Person or the Person's designee and must include the following information:

(a) the Person's full name, current mailing and email address and telephone number;

- (b) if the Person seeking to opt out is a corporation, the name of the corporation and the position of the Person submitting the request to opt out on behalf of the corporation; and
 - (c) a statement to the effect that the Person wishes to be excluded from the Action.

- 9. If the written request under paragraph 8 is sent by mail and the postmark is not visible or legible, the request to opt out shall be deemed to have been postmarked seven (7) business days prior to the date that it is received by Class Counsel.

- 10. Any putative Settlement Class member who validly opts out of this Action shall have no further right to participate in the Action or to share in the distribution of any funds received as a result of the Settlement Agreement.

- 11. No further right to opt out of this action will be provided.

- 12. In accordance with Rule 334.21(2), a Settlement Class member shall be deemed to have opted out from this action if the Settlement Class member does not, before expiry of the Opt-Out Deadline, discontinue a proceeding brought by the Settlement Class member that raises the common issue set out in paragraph 7 of this Order.

- 13. Within thirty (30) days of the Opt-Out Deadline, Class Counsel shall provide to the Settling Defendants a report containing the names of each Person who has validly and timely opted out of this Action and a summary of the information received from such Persons pursuant to paragraph 8 above.

14. This order and any reasons given by the Court in connection with it and the certification of this action for settlement purposes are without prejudice to the Settling Defendants' rights to contest any aspect of the allegations and the claims asserted in any other proceeding in any jurisdiction.
15. The Notice of Certification and Settlement Approval Hearing is approved substantially in the form attached hereto as **Schedule "B"**.
16. The Notice Plan is approved in the form attached hereto as **Schedule "C"**.
17. The Notice of Certification and Settlement Approval Hearing shall be disseminated in accordance with the Notice Plan.
18. The Settling Defendants are authorized to make disclosure to Class Counsel and/or any Court-appointed notice provider and/or the Claims Administrator in accordance with section 10.3 of the Settlement Agreement.
19. This order shall be set aside, declared null and void and of no force and effect in respect of the Settling Defendants on subsequent motion made on notice in the event that the Settlement Agreement is terminated in accordance with its terms.
20. There is no costs order on this motion.

**CAUSTIC SODA NATIONAL CLASS ACTIONS
SETTLEMENT AGREEMENT**

RECITALS

- A. WHEREAS the Proceedings have been commenced by the Plaintiffs;
- B. AND WHEREAS the Proceedings allege that the Defendants and unnamed co-conspirators participated in an unlawful conspiracy to fix, maintain, increase or control the price of Caustic Soda in North America from October 1, 2015 to February 29, 2020, contrary to Part VI of the *Competition Act* and the common law and/or the civil law;
- C. AND WHEREAS the Federal Court Action was discontinued as against Occidental Petroleum Corporation;
- D. AND WHEREAS the Quebec Action was suspended pending authorization and related proceedings in the Federal Court Action;
- E. AND WHEREAS the Settling Defendants and Releasees do not admit, through the execution of this Settlement Agreement or otherwise, any allegation of unlawful conduct alleged in the Proceedings and deny all liability and assert that they have complete defences in respect of the merits of the Proceedings or otherwise;
- F. AND WHEREAS despite their belief that they are not liable in respect of the claims as alleged or previously alleged in the Proceedings, and have good and reasonable defences in respect of jurisdiction and the merits, the Settling Defendants are entering into this Settlement Agreement in order to achieve a final and nation-wide resolution of all claims which have been asserted or which could have been asserted against the Releasees by the Plaintiffs and the Settlement Class in the Proceedings, and to avoid further expense, inconvenience, the distraction of burdensome and protracted litigation, and the risks associated with trials and appeals;
- G. AND WHEREAS Counsel for the Settling Defendants and Class Counsel participated in an all-party mediation with a judicial mediator and subsequently engaged in arm's-length settlement discussions and negotiations with respect to the Proceedings, resulting in this Settlement Agreement;
- H. AND WHEREAS the Plaintiffs and Class Counsel have reviewed and fully understand the terms of this Settlement Agreement and, based on their analyses of the facts and law applicable to the Plaintiffs' claims, and having regard to the burdens and expense in prosecuting the Proceedings, including the risks and uncertainties associated with trials and appeals, and having regard to the value of the Settlement Agreement, the Plaintiffs and Class Counsel have concluded that this Settlement Agreement is fair, reasonable and in the best interests of the Plaintiffs and the Settlement Class they seek to represent;
- I. AND WHEREAS the Plaintiffs, Class Counsel and the Settling Defendants agree that neither this Settlement Agreement nor any statement made in the negotiation thereof shall be deemed or construed to be an admission by or evidence against the Releasees or evidence of the

truth of any of the Plaintiffs' allegations against the Releasees, which allegations are expressly denied by the Releasees;

J. AND WHEREAS the Parties therefore wish to, and hereby do, finally resolve on a national basis, without admission of liability, all of the Proceedings as against the Releasees;

K. AND WHEREAS the Plaintiffs assert that they are adequate class representatives for the Settlement Class and will seek to be appointed representative plaintiffs;

L. AND WHEREAS the Settling Defendants do not hereby attorn to the jurisdiction of Federal Court or any other court or tribunal in respect of any civil, criminal or administrative process except to the extent they have previously done so in the Proceedings and as is expressly provided in this Settlement Agreement with respect to the Proceedings;

M. AND WHEREAS the Parties consent to certification of the Federal Court Action for the sole purpose of implementing this Settlement Agreement, as provided for in this Settlement Agreement, on the express understanding that such certification shall not derogate from the respective rights of the Parties in the event that this Settlement Agreement is not approved, is terminated or otherwise fails to take effect for any reason;

N. AND WHEREAS the Parties consent to the discontinuance of the Quebec Action without costs;

O. AND WHEREAS as a result of their settlement discussions and negotiations, the Settling Defendants and the Plaintiffs have entered into this Settlement Agreement, which embodies all of the terms and conditions of the settlement between the Settling Defendants and the Plaintiffs, both individually and on behalf of the Settlement Class the Plaintiffs seek to represent;

NOW THEREFORE, in consideration of the covenants, agreements and releases set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed by the Parties that the Federal Court Action be settled and dismissed with prejudice as against the Settling Defendants and Releasees and that the Quebec Action be discontinued, all without costs as to the Plaintiffs, the Settlement Class they seek to represent and the Settling Defendants, subject to the approval of the Federal Court, on the following terms and conditions:

SECTION 1 – DEFINITIONS

For the purpose of this Settlement Agreement only, including the recitals and schedules:

(1) *Administration Expenses* means all fees, disbursements, expenses, costs, taxes and any other amounts incurred or payable by the Plaintiffs, Class Counsel or otherwise for the approval, implementation and operation of this Settlement Agreement, including the costs of notices and the costs of claims administration, but excluding Class Counsel Fees and Class Counsel Disbursements.

(2) *Affiliates*, with respect to a company, includes all other entities which, whether directly or indirectly, (i) are controlled by that company, (ii) are under common control with that company or

(iii) control that company. The term “control” as used in this definition means the power to individually or jointly with another entity direct or cause the direction of the management and the policies of an entity, whether through the ownership of a majority of the outstanding voting rights or otherwise.

(3) **Approval Hearing** means the hearing brought by Class Counsel for the Federal Court’s approval of the settlement provided for in this Settlement Agreement.

(4) **Caustic Soda** means the chemical compound sodium hydroxide (NaOH), sold in both liquid and solid forms, and products containing or derived from caustic soda.

(5) **Claims Administrator** means the firm proposed by the Plaintiffs and appointed by the Federal Court to administer the Settlement Amount in accordance with the provisions of this Settlement Agreement and the Distribution Protocol, and any employees of such firm. Alternatively, if Class Counsel determines that it would be more cost-effective to administer the Settlement Amount themselves, Claims Administrator means Class Counsel.

(6) **Class Counsel** means Siskinds LLP and Siskinds Desmeules s.e.n.c.r.l.

(7) **Class Counsel Disbursements** include the disbursements and applicable taxes incurred by Class Counsel in the prosecution of the Proceedings, as well as any adverse costs awards issued against the Plaintiffs in any of the Proceedings.

(8) **Class Counsel Fees** means the fees of Class Counsel, and any applicable taxes or charges thereon, including any amounts payable as a result of the Settlement Agreement by Class Counsel or the Settlement Class to any other body or Person, in relation to legal fees.

(9) **Class Period** means October 1, 2015 to the date of the order certifying the Federal Court Action against the Settling Defendants for settlement purposes.

(10) **Common Issue** means: Did the Settling Defendants conspire to fix, maintain, increase or control the price of Caustic Soda directly or indirectly during the Class Period?

(11) **Counsel for the Settling Defendants** means the counsel listed for the Defendants in section 12.17 of the Settlement Agreement.

(12) **Defendants** means the entities currently or formerly named as defendants in the Proceedings as set out in Schedule "A" to this Settlement Agreement. For greater certainty, Defendants includes, without limitation, the Settling Defendants, the other Releasees who are named as Defendants, and Defendants in respect of whom one or more of the Proceedings has been discontinued.

(13) **Distribution Protocol** means the plan for distributing the Settlement Amount and accrued interest, in whole or in part, as proposed by Class Counsel and as approved by the Federal Court.

(14) **Effective Date** means the date when the Settlement Approval Order has become a Final Order and the discontinuance has been entered by Class Counsel with the Quebec Superior Court in the Quebec Action.

(15) **Execution Date** means the date on the cover page as of which the Parties have executed this Settlement Agreement.

(16) **Excluded Person** means each Defendant, the directors and officers of each Defendant, the subsidiaries or Affiliates of each Defendant, the entities in which each Defendant or any of that Defendant's subsidiaries or Affiliates have a controlling interest and the legal representatives, heirs, successors and assigns of each of the foregoing.

(17) **Federal Court Action** means the action commenced in the Federal Court in Court File T-1365-20 as listed in Schedule "A" to this Settlement Agreement.

(18) **Federal Court Plaintiff** means Topher's Beard Company.

(19) **Final Order** means the Settlement Approval Order that either (i) has not been appealed before the time to appeal such order has expired, if an appeal lies, or (ii) has been affirmed upon a final disposition of all appeals. For further certainty, any order made by the Federal Court approving this Settlement Agreement will not become a Final Order until the time to appeal such an order has expired without any appeal having been taken or until the order has been affirmed upon a final disposition of all appeals.

(20) **Fonds d'aide** means the Fonds d'aide aux actions collectives in Quebec which is entitled to receive the value in dollars of a percentage of the share of any *cy pres* distribution that would otherwise be allocated to the Quebec class members pursuant to the *Regulation respecting the percentage withheld by the Fonds d'aide aux actions collectives*.

(21) **Notice of Certification and Settlement Approval Hearing** means the form of notice agreed to by the Plaintiffs and the Settling Defendants and as approved by the Federal Court, to inform the Settlement Class of: (i) certification for settlement purposes of the Federal Court Action; (ii) the process by which Settlement Class members may opt-out of the Settlement Agreement; (iii) the date and location of the Approval Hearing; (iv) the principal elements of the Settlement Agreement; and (v) the process by which Settlement Class members may object to the Settlement Agreement.

(22) **Notice of Settlement Approval** means the form of notice agreed to by the Plaintiffs and the Settling Defendants, or such other forms of notice as may be approved by the Federal Court, which informs the Settlement Class of: (i) the approval of this Settlement Agreement; and (ii) the process by which Settlement Class members may apply to obtain compensation from the Settlement Amount.

(23) **Opt-Out** means a prospective Settlement Class member who has submitted a valid written election to opt out of the Settlement Agreement by the Opt-Out Deadline.

(24) **Opt-Out Deadline** means thirty (30) days from the dissemination of the Notice of Certification and Settlement Approval Hearing.

(25) **Other Actions** means actions or proceedings, excluding the Proceedings, relating to the Released Claims, commenced by a Settlement Class member either before or after the Effective Date.

(26) **Party or Parties** means the Plaintiffs, Settlement Class members (where appropriate) or the Settling Defendants.

(27) **Person** means an individual, corporation, partnership, limited partnership, limited liability company, association, joint stock company, estate, legal representative, trust, trustee, executor, beneficiary, unincorporated association, government or any political subdivision or agency thereof, and any other business or legal entity and their heirs, predecessors, successors, representatives, or assignees.

(28) **Plaintiffs** means the Federal Court Plaintiff and Quebec Plaintiff.

(29) **Proceedings** means the Federal Court Action and the Quebec Action.

(30) **Purchase Price** means the sale price paid by direct purchaser Settlement Class members for Caustic Soda purchased in Canada during the Class Period, less any rebates, delivery or shipping charges, taxes and any other form of discounts.

(31) **Quebec Action** means the proceeding filed in the Quebec Superior Court listed in Schedule "A" to this Settlement Agreement.

(32) **Quebec Plaintiff** means Florence Moreault.

(33) **Released Claims** means any and all manner of claims, demands, actions, suits, causes of action, whether class, individual or otherwise in nature (whether or not any Settlement Class member has objected to this Settlement Agreement or makes a claim upon or received a payment from the Settlement Amount, whether directly, representatively, derivatively or in any other capacity), whether personal or subrogated, damages of any kind (including compensatory, punitive or other damages) whenever incurred, liabilities of any nature whatsoever, including interest, costs, expenses, class administration expenses (including Administration Expenses), penalties, and lawyers' fees (including Class Counsel Fees and Class Counsel Disbursements), known or unknown, suspected or unsuspected, actual or contingent, and liquidated or unliquidated, in law, under statute or in equity, that any of the Releasors ever had, now have or hereafter can, shall or may have on account of, or in any way related to the purchase, sale, pricing, discounting, producing marketing, offering or distributing of Caustic Soda, including all claims for consequential, subsequent or follow-on harm that arises after the date hereof in respect of any agreement, combination, conspiracy or conduct that occurred prior to the date hereof, including the conduct alleged (or which was previously or could have been alleged) in the Proceedings or any pleading therein. However, nothing herein shall be construed to release any claims involving negligence, personal injury, failure to deliver goods, damaged or delayed goods, product defect, securities, breach of contract, bailment, breach of warranty or other similar claim relating to Caustic Soda but not relating to alleged anti-competitive conduct.

(34) **Releasees** means, jointly and severally, solidarily, individually and collectively, the Defendants, their Affiliates, and any named or unnamed co-conspirators, and each of their respective past and present, direct and indirect, parents, subsidiaries, partners, insurers, divisions, branches, associates, joint ventures, franchisees, dealers, and all other Persons, partnerships or corporations with whom any of the foregoing have been, or are now, affiliated, and all of their respective past, present and future officers, directors, employees, agents, mandataries,

shareholders, attorneys, trustees, insurers, servants and representatives, members and managers, and the predecessors, successors, purchasers, heirs, executors, administrators and assigns of each of the foregoing.

(35) **Releasors** means, jointly and severally, solidarily, individually and collectively, the Plaintiffs and the Settlement Class on behalf of themselves and any Person or entity claiming by or through them including a parent, subsidiary, affiliate, predecessor, successor, shareholder, partner, director, owner of any kind, agent, principal, employee, contractor, attorney, heir, executor, administrator, insurer, devisee, assignee, or representative of any kind, other than any Opt-Out.

(36) **Settlement Agreement** means this agreement, including the recitals and schedules.

(37) **Settlement Amount** means the sum of two million, ninety-five thousand, three hundred and fifty Canadian dollars (CAD \$2,095,350.00).

(38) **Settlement Approval Order** means the form of order approving the Settlement Agreement at **Schedule “C”** to this Settlement Agreement.

(39) **Settlement Class** means all Persons in Canada who purchased Caustic Soda during the Class Period except the Excluded Persons and any Opt-Out.

(40) **Settling Defendants** means Olin Corporation, K.A. Steel Chemicals, Inc., Olin Canada ULC, 3229897 Nova Scotia Co. (the “**Olin Defendants**”); Occidental Chemical Corporation, Oxy Canada Sales Inc. (the “**OxyChem Defendants**”); Westlake Chemical Corporation, Axiall Canada, Inc. (the “**Westlake Defendants**”); Formosa Plastics Corporation, Formosa Plastics Corporation, U.S.A. (the “**Formosa Defendants**”); Shin-Etsu Chemical Co., Ltd. and Shintech Incorporated (the “**Shintech Defendants**”)

(41) **Trust Account** means a guaranteed investment vehicle, liquid money market account or equivalent security with a rating equivalent to or better than that of a Canadian Schedule I bank (a bank listed in Schedule I of the *Bank Act*, SC 1991, c 46) held at a Canadian financial institution under the control of Siskinds LLP or the Claims Administrator, once appointed, for the benefit of the Settlement Class or the Settling Defendants, as provided for in this Settlement Agreement.

SECTION 2 - SETTLEMENT APPROVAL

2.1 Best Efforts

(1) The Parties shall use their best efforts to implement this Settlement Agreement, to secure the prompt, complete and final dismissal with prejudice of the Federal Court Action, and to obtain a discontinuance of the Quebec Action.

2.2 Motions for Approval

(1) As soon as practical after the Settlement Agreement is executed, the Federal Court Plaintiff shall file a motion before the Federal Court for an order certifying the Federal Court Action as a class proceeding for settlement purposes and approving the Notice Plan and the Notice of

Certification and Settlement Approval Hearing, in the form agreed to by the Plaintiffs and the Settling Defendants. The order shall be substantially in the form attached as **Schedule "B"**.

(2) The Federal Court Plaintiff shall file a motion before the Federal Court for an order approving this Settlement Agreement as soon as practicable after:

- (a) the order referred to in section 2.2(1) has been granted; and
- (b) the Notice of Certification and Settlement Approval Hearing has been published.

The order approving this Settlement Agreement shall be substantially in the form attached as **Schedule "C"**.

(3) As soon as practicable after the Federal Court has issued an order approving this Settlement Agreement, the Quebec Plaintiff will move to discontinue the Quebec Action.

(4) This Settlement Agreement shall only become final on the Effective Date.

2.3 Pre-Motion Confidentiality

(1) Until the motion required by section 2.2(1) is brought, the Parties shall keep all of the terms of the Settlement Agreement confidential and shall not disclose them without the prior consent of Counsel for the Settling Defendants or Class Counsel, as the case may be, except as required for the purposes of financial reporting or the preparation of financial records (including tax returns and financial statements), as otherwise required by law, or as otherwise required to give effect to the terms of this Settlement Agreement.

SECTION 3 – SETTLEMENT CONSIDERATION

3.1 Payment of Settlement Amount

(1) Within thirty (30) days following the Execution Date, or the date of receipt of the wire transfer information from Class Counsel, whichever is later, the Settling Defendants shall pay the Settlement Amount to Siskinds LLP for deposit into the Trust Account.

(2) The Settling Defendants shall pay the Settlement Amount by wire transfer. Siskinds LLP shall provide the necessary wire transfer information to Counsel for the Settling Defendants in writing within ten (10) days following the Execution Date.

(3) The Settlement Amount and other consideration to be provided in accordance with the terms of this Settlement Agreement shall be provided in full satisfaction of the Released Claims against the Releasees.

(4) The Settlement Amount represents the full amount to be paid pursuant to this Settlement Agreement and shall be all-inclusive of all amounts, including without limitation, Class Counsel Fees, Class Counsel Disbursements, any honoraria for the Plaintiffs, any distributed amounts to the Settlement Class, any *cy pres* distributions, and Administration Expenses.

- (5) The Settling Defendants and other Releasees shall have no obligation to pay any amount in addition to the Settlement Amount to be paid by the Settling Defendants, for any reason, pursuant to or in furtherance of this Settlement Agreement, the Proceedings or any Other Actions.
- (6) Once a Claims Administrator has been appointed, Class Counsel shall transfer control of the related portion of the Trust Account to the Claims Administrator.
- (7) Class Counsel and/or the Claims Administrator shall maintain the Trust Account as provided for in this Settlement Agreement. While in control of the Trust Account, Class Counsel and/or the Claims Administrator shall not pay out all or part of the monies in the Trust Account, except in accordance with this Settlement Agreement, or in accordance with an order of the Federal Court obtained after notice to the Parties.

3.2 Taxes and Interest

- (1) Except as hereinafter provided, all interest earned on the Settlement Amount in the Trust Account shall accrue to the benefit of the Settlement Class and shall become and remain part of the Trust Account.
- (2) All taxes payable on any interest which accrues on the Settlement Amount in the Trust Account or otherwise in relation to the Settlement Amount shall be paid from the Trust Account. Class Counsel and/or the Claims Administrator shall be solely responsible to fulfill all tax reporting and payment requirements arising from the Settlement Amount in the Trust Account, including any obligation to report taxable income and make tax payments. All taxes (including interest and penalties) due with respect to the income earned by the Settlement Amount shall be paid from the Trust Account.
- (3) The Settling Defendants shall have no responsibility to make any filings relating to the Trust Account and will have no responsibility to pay tax on any income earned on the Settlement Amount or pay any taxes on the monies in the Trust Account, unless this Settlement Agreement is not approved, is terminated, or otherwise fails to take effect for any reason, in which case the interest earned on the Settlement Amount in the Trust Account or otherwise shall be paid to the Settling Defendants who, in such case, shall be responsible for the payment of all taxes on such interest not previously paid by Class Counsel or the Claims Administrator.

SECTION 4 – OPTING OUT

4.1 Procedure

- (1) Class Counsel will seek approval from the Federal Court of the following opt-out process as part of the order certifying the Federal Court Action as a class proceeding for settlement purposes:
 - (a) Persons seeking to opt out of the Federal Court Action must do so by sending a written election to opt out, signed by the Person or the Person's designee, by pre-paid mail, courier, or email to Class Counsel at addresses to be identified in the Notice of Certification and Settlement Approval Hearing.

- (b) An election to opt out sent by mail or courier will only be valid if it is postmarked on or before the Opt-Out Deadline to the designated address in the Notice of Certification and Settlement Approval Hearing. Where the postmark is not visible or legible, the election to opt out shall be deemed to have been postmarked seven (7) business days prior to the date that it is received by Class Counsel.
 - (c) The written election to opt out must contain the following information in order to be valid:
 - (A) the Person's full name, current mailing and email address, and telephone number;
 - (B) if the Person seeking to opt out is a corporation, the name of the corporation and the position of the Person submitting the request to opt out on behalf of the corporation; and
 - (C) a statement to the effect that the Person wishes to be excluded from the Federal Court Action.
 - (d) Any putative Settlement Class member who validly opts out of the Federal Court Action shall be excluded from the Federal Court Action and the Class and will not have the opportunity to benefit from the Settlement Agreement.
 - (e) Any putative Settlement Class member who does not validly opt out of the Federal Court Action in the manner and time prescribed above, shall be deemed to have elected to participate in the Federal Court Action, including this Settlement Agreement.
 - (f) Within thirty (30) days of the Opt-Out Deadline, Class Counsel shall provide to the Settling Defendants a report containing the names of each Person who has validly and timely opted out of the Federal Court Action, the reasons for the opt-out, if known, and a summary of the information delivered by such Persons pursuant to this Section 4.1.
- (2) The Parties will not, directly or indirectly, encourage or cause any Person to opt out of the Federal Court Action.

SECTION 5 – NON-APPROVAL OR TERMINATION OF SETTLEMENT AGREEMENT

5.1 Right of Termination

- (1) In the event that:
 - (a) the Federal Court declines to certify the Federal Court Action for settlement purposes as against the Settling Defendants in accordance with the Settlement Agreement;

- (b) the Federal Court declines to dismiss the Federal Court Action;
- (c) the Federal Court declines to approve this Settlement Agreement or any material part hereof;
- (d) the Federal Court issues a settlement approval order that is materially inconsistent with the terms of the Settlement Agreement or not substantially in the form attached to this Settlement Agreement as Schedule "C";
- (e) the order approving this Settlement Agreement made by the Federal Court does not become a Final Order; and/or
- (f) the Quebec Plaintiff does not discontinue the Quebec Action;

the Plaintiffs and each of the Settling Defendants shall each have the right to terminate this Settlement Agreement on the grounds above (except that only a Settling Defendant shall have the right to terminate under subsections (b) and (f)) by delivering a written notice pursuant to section 12.17, within thirty (30) days following an event described above.

(2) In addition, if the Settlement Amount is not paid in accordance with section 3.1(1), the Plaintiffs shall have the right to terminate this Settlement Agreement by delivering a written notice pursuant to section 12.17, within thirty (30) days after such non-payment, or move before the Federal Court to enforce the terms of this Settlement Agreement.

(3) Any order, ruling or determination made (or rejected) by the Federal Court with respect to the Distribution Protocol and/or Class Counsel Fees or Class Counsel Disbursements shall not be deemed to be a material modification of all, or a part, of this Settlement Agreement and shall not provide any basis for the termination of this Settlement Agreement.

5.2 If Settlement Agreement is Terminated

(1) If this Settlement Agreement is not approved, is terminated in accordance with its terms or otherwise fails to take effect for any reason:

- (a) any motion to certify the Federal Court Action as a class proceeding on the basis of this Settlement Agreement or to approve this Settlement Agreement, which has not been decided, shall not proceed;
- (b) the Parties will cooperate in seeking to have any issued order certifying the Federal Court Action as a class proceeding on the basis of the Settlement Agreement or approving this Settlement Agreement set aside and declared null and void and of no force or effect, and any Party (including the Settlement Class) shall be estopped from asserting otherwise; and
- (c) any prior certification of the Federal Court Action as a class proceeding pursuant to this Settlement Agreement shall be without prejudice to any position that any of the Parties or Releasees may later take on any issue in the Proceedings or Other Actions or other litigation.

(2) If the Settlement Agreement is not approved, is terminated or otherwise fails to take effect for any reason, Class Counsel shall, within thirty (30) business days of the written notice advising that the Settlement Agreement has been terminated in accordance with its terms, return to the Settling Defendants the Settlement Amount, plus all accrued interest thereon, less taxes paid on interest, and less any notice costs already incurred with respect to the notices described in section 9.1(1) and any costs already incurred with respect to translating the Settlement Agreement. The Settling Defendants will allocate the remaining Settlement Amount amongst themselves.

(3) Except as provided for in section 5.3, if the Settling Defendants or the Plaintiffs exercise their right to terminate, the Settlement Agreement shall be null and void and have no further force or effect, shall not be binding on the Parties, and shall not be used as evidence or otherwise in any litigation or in any other way for any reason.

5.3 Survival of Provisions After Termination

(1) If this Settlement Agreement is not approved, is terminated or otherwise fails to take effect for any reason, the provisions of sections 3.2(3), 5.2, 5.3, 7.1, 7.2, 9.1, 10.3(5), and 12.4, and the definitions and schedules applicable thereto shall survive the termination and continue in full force and effect. The definitions and schedules shall survive only for the limited purpose of the interpretation of sections 3.2(3), 5.2(3), 5.3, 7.1, 7.2, 9.1, 10.3(5), and 12.4 within the meaning of this Settlement Agreement, but for no other purposes. All other provisions of this Settlement Agreement and all other obligations pursuant to this Settlement Agreement shall cease immediately.

SECTION 6 – RELEASES AND DISMISSALS

6.1 Release of Releasees

(1) Upon the Effective Date, and in consideration of payment of the Settlement Amount, and for other valuable consideration set forth in the Settlement Agreement, the Releasers: (a) shall have forever and absolutely released the Releasees from the Released Claims that any of them, whether directly, indirectly, derivatively, or in any other capacity, ever had, now have, or hereafter can, shall, or may have; (b) shall forever be enjoined from prosecuting in any forum any Released Claim against any of the Releasees; and (c) agree and covenant not to sue any of the Releasees on the basis of any Released Claims or to assist any third party in commencing or maintaining any suit against any Releasees related in any way to Released Claims.

(2) The Plaintiffs and Settlement Class acknowledge that they may hereafter discover facts in addition to, or different from, those facts which they know or believe to be true regarding the subject matter of the Proceedings and the Settlement Agreement, and it is their intention to release fully, finally and forever all Released Claims and, in furtherance of such intention, this release shall be and remain in effect notwithstanding the discovery or existence of additional or different facts.

6.2 Release by Releasees

(1) Upon the Effective Date, each Releasee forever and absolutely releases each of the other Releasees from any and all claims for contribution or indemnity with respect to the Released Claims.

6.3 No Further Claims

(1) Upon the Effective Date, each Releasor shall not institute, prosecute, continue, maintain, intervene in or assert, either directly or indirectly, whether in Canada or elsewhere, on their own behalf or on behalf of any class or any other Person, any proceeding, cause of action, claim, suit, complaint or demand against any Releasee or any other Person who may claim contribution or indemnity or other claims over relief from any Releasee, whether pursuant to any provincial or federal negligence acts or similar legislation or at common law or equity, in respect of any Released Claim, and are permanently barred and enjoined from doing so. For greater certainty and without limiting the generality of the foregoing, the Releasors shall not assert or pursue a Released Claim against any Releasee under the laws of any foreign jurisdiction.

6.4 Dismissals and Discontinuances

(1) Upon the Effective Date, the Federal Court Action shall be dismissed with prejudice and without costs as against the Defendants named in that action.

(2) As soon as practical after the Federal Court has issued an order approving this Settlement Agreement, the Quebec Plaintiff will move to discontinue Quebec Action.

(3) Upon the Effective Date, each Settlement Class member shall be deemed to irrevocably consent to the dismissal, without costs, with prejudice and without reservation, of his, her or its Other Actions against the Releasees.

(4) Upon the Effective Date, Settlement Class Members agree that all Other Actions shall be dismissed as against the Releasees, without costs, with prejudice and without reservation.

6.5 Material Terms

(1) For the avoidance of doubt and without in any way limiting the ability of the Parties to assert that other terms in this Settlement Agreement are material terms (subject to section 5.1(3)), the releases, covenants, dismissals and discontinuances in this section 6 shall be considered material terms of the Settlement Agreement and the failure of the Federal Court to approve the releases, covenants and dismissals or the failure to obtain a discontinuance of the Quebec Action contemplated herein shall give rise to a right of termination pursuant to section 5.1 of the Settlement Agreement.

SECTION 7 – EFFECT OF SETTLEMENT

7.1 No Admission of Liability

(1) The Plaintiffs and the Releasees expressly reserve all of their rights if this Settlement Agreement is not approved, is terminated or otherwise fails to take effect for any reason. Further, whether or not this Settlement Agreement is finally approved, is terminated, or otherwise fails to take effect for any reason, this Settlement Agreement and anything contained herein, and any and all negotiations, documents, discussions and proceedings associated with this Settlement Agreement, and any action taken to carry out this Settlement Agreement, shall not be deemed, construed or interpreted to be an admission of any violation of any statute or law, or of any wrongdoing or liability by the Releasees, or of the truth of any of the claims or allegations contained in the Proceedings or any other actions against the Releasees.

7.2 Agreement Not Evidence

(1) The Parties agree that, whether or not it is finally approved, is terminated, or otherwise fails to take effect for any reason, this Settlement Agreement and anything contained herein, and any and all negotiations, documents, discussions and proceedings associated with this Settlement Agreement, and any action taken to carry out this Settlement Agreement, shall not be referred to, offered or received as evidence in any pending or future civil, criminal or administrative action or proceeding, except in a proceeding to approve and/or enforce this Settlement Agreement, or to defend against the assertion of Released Claims, as necessary in any insurance-related proceeding, or as otherwise required by law or as provided in this Settlement Agreement.

7.3 No Further Litigation

(1) No Class Counsel, nor anyone currently or hereafter employed by, or a partner of Class Counsel, may directly or indirectly participate or be involved in or in any way assist with respect to any claim made or action commenced by any Person against the Settling Defendants or the Releasees that relates to or arises from the Released Claims. Moreover, neither Class Counsel, nor anyone currently or hereafter employed by, or a partner of Class Counsel, may divulge to anyone for any purpose, or use for any purpose, any information obtained in the course of the Proceedings or the negotiation and preparation of this Settlement Agreement, except to the extent that such information was, is or becomes otherwise publicly available or unless ordered to do so by a court in Canada.

(2) Section 7.3(1) shall be inoperative to (and only to) the extent that it is inconsistent with Class Counsel's obligations under Rule 3.2-10 of the Code of Professional Conduct for British Columbia.

SECTION 8 - CERTIFICATION FOR SETTLEMENT ONLY

8.1 Settlement Class and Common Issue

(1) The Parties agree that the Federal Court Action shall be certified as a class proceeding as against the Settling Defendants solely for purposes of settlement of the Proceedings and the approval of this Settlement Agreement by the Federal Court.

(2) The Plaintiffs agree that, in the motion for certification of the Federal Court Action as a class proceeding for settlement purposes and for the approval of this Settlement Agreement, the only common issue that they will seek to define is the Common Issue and the only class that they will assert is on behalf of the Settlement Class.

SECTION 9 – NOTICE TO CLASS

9.1 Notices Required

(1) The Settlement Class shall be given the following notices: (i) Notice of Certification and Settlement Approval Hearing; (ii) Notice of Settlement Approval; and (iii) notice of termination, if this Settlement Agreement is not approved, is terminated, or otherwise fails to take effect; and (iv) such further notice as may be directed by the Federal Court.

9.2 Form and Distribution of Notices

(1) The manner in which the Notice of Certification and Settlement Approval Hearing will be disseminated shall be included in the Notice Plan, in the form agreed on by the Plaintiffs and Settling Defendants, and as approved by the Federal Court.

(2) The Notice of Certification and Settlement Approval Hearing shall be agreed on by the Plaintiffs and Settling Defendants and as approved by the Federal Court.

(3) The Notice of Settlement Approval and the manner in which the Notice of Settlement Approval will be disseminated shall be agreed to by the Parties and as approved by the Federal Court, or if the Parties cannot agree, then such form or manner as approved by the Federal Court.

(4) The Parties will cooperate in the preparation of any communications to the press in relation to the Settlement Agreement or the Proceedings.

9.3 Notice Costs

(1) All notice costs shall be paid from the Settlement Amount.

SECTION 10 – ADMINISTRATION AND IMPLEMENTATION

10.1 Mechanics of Administration

(1) Except to the extent provided for in this Settlement Agreement, the mechanics of the implementation and administration of this Settlement Agreement and the Distribution Protocol shall be determined by the Federal Court on motions brought by Class Counsel.

(2) The Releasees shall not have any responsibility, financial obligations or liability whatsoever with respect to the investment, distribution or administration of monies in the Trust Account including, but not limited to, Administration Expenses and Class Counsel Fees.

10.2 Distribution Protocol

(1) On notice to the Settling Defendants, Class Counsel will make an application seeking an order from the Federal Court approving the Distribution Protocol. The motion can be brought before the Effective Date, but the order approving the Distribution Protocol shall be conditional on the Effective Date occurring.

(2) The Distribution Protocol will address the timelines and process for making and approving eligible claims, distributing settlement funds to approved claimants, and allocating any undistributed settlement funds, including any required distributions to the Fonds d'aide, a Class Proceedings Fund, and/or a Law Foundation in Canada.

10.3 Information and Assistance

(1) The Settling Defendants will make reasonable efforts to provide Class Counsel with a list of the available names and addresses for their direct purchaser Settlement Class members in Canada during the Class Period, together with information regarding the Purchase Price paid by each such Settlement Class member.

(2) The Settling Defendants shall provide the list of the available names and addresses referenced in 10.3(1) to Class Counsel and/or any Court-appointed notice provider and/or the Claims Administrator within thirty (30) days after the order certifying the Federal Court Action as a class proceeding for settlement purposes and approving the Notice Plan and the Notice of Certification and Settlement Approval Hearing. The Settling Defendants shall provide the Purchase Price information referenced in 10.3(1) to Class Counsel and/or the Claims Administrator within thirty (30) days after the Effective Date.

(3) The information shall be delivered by the Settling Defendants to Class Counsel and/or any Court-appointed notice provider and/or the Claims Administrator in the form it currently exists via secure file transfer, or in Microsoft Excel format or such other format as may be agreed upon by Counsel for the Settling Defendants and Class Counsel.

(4) The available names and contact information referenced in 10.3(1) shall be collected, used and retained pursuant to privacy laws in Canada for the purposes of administering the Settlement Agreement, disseminating the notices required in section 9.1(1), and evaluating eligibility status under the Settlement Agreement.

(5) All information provided pursuant to section 10.3(1) shall be treated as private and confidential by Class Counsel or any Court-appointed notice provider and/or the Claims Administrator and shall not be disclosed except in accordance with the Settlement Agreement, the Distribution Protocol and orders of the Federal Court. If this Settlement Agreement is terminated, all information provided by a Settling Defendant shall be returned to it and no record of the information so provided shall be retained by Class Counsel or any Court-appointed notice provider and/or the Claims Administrator in any form whatsoever.

(6) The Settling Defendants will make themselves reasonably available to respond to questions respecting the information provided pursuant to section 10.3(1) from Class Counsel or any Court-appointed notice provider and/or the Claims Administrator. The Settling Defendants' obligations

to make themselves reasonably available to respond to questions as particularized in this section shall not be affected by the release provisions contained in section 6 of this Settlement Agreement. Unless this Settlement Agreement is not approved, is terminated or otherwise fails to take effect for any reason, the Settling Defendants' obligations to cooperate pursuant to this section 10.3 shall cease when all settlement funds have been distributed.

(7) The Settling Defendants shall bear no liability with respect to the completeness or accuracy of the information provided pursuant to this section 10.3 and make no representation or admission that the persons listed are Settlement Class members.

SECTION 11 – CLASS COUNSEL FEES, DISBURSEMENTS AND ADMINISTRATION EXPENSES

11.1 Court Approval for Class Counsel Fees and Disbursements

(1) Class Counsel may seek the Federal Court's approval to pay Class Counsel Disbursements and Class Counsel Fees contemporaneous with seeking approval of this Settlement Agreement. Class Counsel Disbursements and Class Counsel Fees shall be reimbursed and paid solely out of the Trust Account after the Effective Date.

(2) Class Counsel reserve the right to bring motions to the Federal Court for reimbursement out of the Trust Account for any future Class Counsel Disbursements.

11.2 Responsibility for Fees, Disbursements and Taxes

(1) The Releasees shall not be liable for any Class Counsel Fees, Class Counsel Disbursements or taxes of any of the lawyers, experts, advisors, agents, or representatives retained by Class Counsel, the Plaintiffs or the Settlement Class, any amounts to which a Class Proceedings Fund, Law Foundation or the Fonds d'aide in Quebec may be entitled, or any lien of any Person on any payment to any Settlement Class member from the Settlement Amount.

11.3 Administration Expenses

(1) Except as provided herein, Administration Expenses may only be paid out of the Trust Account after the Effective Date.

(2) Class Counsel shall pay the costs of the notices required by section 9.1(1) and translation costs, if any, from the Trust Account, as they become due. Subject to section 5.2(2), the Releasees shall not have any responsibility for the costs of the notices or administration of the Settlement Agreement.

SECTION 12 – MISCELLANEOUS

12.1 Motions for Directions

(1) Class Counsel or the Settling Defendants may apply to the Federal Court as may be required for directions in respect of the interpretation, implementation and administration of this Settlement Agreement.

- (2) All motions contemplated by this Settlement Agreement shall be on notice to the Parties.

12.2 Headings, etc.

- (1) In this Settlement Agreement:
- (a) the division of the Settlement Agreement into sections and the insertion of headings are for convenience of reference only and shall not affect the construction or interpretation of this Settlement Agreement; and
 - (b) the terms “this Settlement Agreement”, “hereof”, “hereunder”, “herein”, and similar expressions refer to this Settlement Agreement and not to any particular section or other portion of this Settlement Agreement.

12.3 Computation of Time

- (1) In the computation of time in this Settlement Agreement, except where a contrary intention appears,
- (a) where there is a reference to a number of days between two events, the number of days shall be counted by excluding the day on which the first event happens and including the day on which the second event happens, including all calendar days; and
 - (b) only in the case where the time for doing an act expires on a holiday as “holiday” is defined in the *Federal Courts Rules*, the act may be done on the next day that is not a holiday.

12.4 Ongoing Jurisdiction

- (1) The Federal Court shall exercise jurisdiction with respect to implementation, administration, interpretation and enforcement of the terms of this Settlement Agreement, and the Plaintiffs, Settlement Class, Settling Defendants, and Releasees named as Defendants attorn to the jurisdiction of the Federal Court for such purposes and no other purpose. Issues related to the administration of the Settlement Agreement and the Trust Account shall be determined by the Federal Court.

12.5 Governing Law

- (1) This Settlement Agreement shall be governed by and construed and interpreted in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.

12.6 Entire Agreement

- (1) This Settlement Agreement constitutes the entire agreement among the Parties, and supersedes all prior and contemporaneous understandings, undertakings, negotiations, representations, promises, agreements, agreements in principle and memoranda of understanding in connection herewith. None of the Parties will be bound by any prior obligations, conditions or

representations with respect to the subject matter of this Settlement Agreement, unless expressly incorporated herein.

12.7 Amendments

(1) This Settlement Agreement may not be modified or amended except in writing and on consent of all Parties hereto, and any such modification or amendment must be approved by the Federal Court.

12.8 Binding Effect

(1) This Settlement Agreement shall be binding upon, and enure to the benefit of, the Plaintiffs, the Settling Defendants, the Settlement Class, the Releasors, the Releasees and all of their successors and assigns. Without limiting the generality of the foregoing, each and every covenant and agreement made herein by the Plaintiffs shall be binding upon all Releasors and each and every covenant and agreement made herein by the Settling Defendants shall be binding upon all of the Releasees.

12.9 Counterparts

(1) This Settlement Agreement may be executed in counterparts, all of which taken together will be deemed to constitute one of the same agreement, and an electronic/PDF signature shall be deemed an original signature for purposes of executing this Settlement Agreement.

12.10 Negotiated Agreement

(1) This Settlement Agreement has been the subject of negotiations and discussions among the undersigned, each of which has been represented and advised by competent counsel, so that any statute, case law, or rule of interpretation or construction that would or might cause any provision to be construed against the drafter of this Settlement Agreement shall have no force and effect. The Parties further agree that the language contained in or not contained in previous drafts of this Settlement Agreement, or any agreement in principle, shall have no bearing upon the proper interpretation of this Settlement Agreement.

12.11 Transaction

(1) This Settlement Agreement constitutes a transaction in accordance with Articles 2631 and following of the *Civil Code of Quebec*, and the Parties are hereby renouncing to any errors of fact, of law and/or of calculation.

12.12 Language



5. The following claims are asserted on behalf of the Settlement Class:
 - a. Claims for loss or damage arising from unlawful conspiracy, under s. 36 of the *Competition Act*.

 - a. Damages in the amount of any unlawful overcharge.
7. The following issue is common to the Settlement Class:

CAUSTIC SODA CLASS ACTIONS

NOTICE OF CERTIFICATION AND SETTLEMENT APPROVAL HEARING

This notice may affect your legal rights. Please read carefully.

THIS NOTICE IS DIRECTED TO:

All persons in Canada who purchased Caustic Soda from October 1, 2015 to [date of consent certification order], except Excluded Persons and any Opt-Out (the "Settlement Class").

Caustic Soda means a basic chemical, also known as sodium hydroxide (NaOH) or lye, sold in solid and liquid form, and products containing or derived from caustic soda. Caustic Soda is used in, among other things, general manufacturing, the production of alumina, soaps, pulp, paper, and textiles, food processing, the refining of petroleum products, and in the inorganic and organic chemical industries.

Excluded Persons means the Defendants and entities related to the Defendants.

Defendants means Olin Corporation, K.A. Steel Chemicals, Inc., Olin Canada ULC, 3229897 Nova Scotia Co., Occidental Chemical Corporation, Oxy Canada Sales Inc., Westlake Chemical Corporation, Axiall Canada, Inc., Formosa Plastics Corporation, Formosa Plastics Corporation, U.S.A., Shin-Etsu Chemical Co., Ltd., and Shintech Incorporated.

Opt-Out means any person who opts out of (excludes themselves from) the class action.

A. Nature of the Class Action

The plaintiff commenced a proposed class proceeding in Federal Court alleging that the Defendants participated in an unlawful conspiracy to fix, raise, maintain, and/or control the price of Caustic Soda contrary to the *Competition Act* (the "Federal Action"). A similar class action was also filed before the Superior Court of Quebec (the "Quebec Action") but was stayed pending a final decision in the Federal Action.

The Defendants deny that they engaged in any unlawful conduct and deny any liability whatsoever in respect of the plaintiffs' claims in the Federal Action and the Quebec Action. The Federal Court has not decided who is right. The plaintiff and all of the Defendants have reached a proposed national settlement to avoid the uncertainties, risks, and costs of further litigation. The representative plaintiffs and Class Counsel consider the settlement to be fair, reasonable and in the best interests of the Settlement Class.

The Federal Action was certified for settlement purposes on behalf of the Settlement Class by the Federal Court by consent order of the Honourable Justice Little on XX, 2025. The certification is conditional on the settlement being approved by the Federal Court. Topher's Beard Company has been appointed as representative plaintiff for the Settlement Class.

If the Settlement is approved by the Federal Court, it will bind all members of the Settlement Class in Canada. Class Counsel will then file a motion before the Superior Court of Quebec seeking permission to discontinue the Quebec action, which will then have become moot.

B. Proposed Settlement

A proposed settlement has been reached with all Defendants in this action in the amount of CAD\$2,095,350.

The settlement is a compromise of disputed claims. If approved, the settlement will settle, extinguish, and bar all claims relating in any way to or arising out of the class action against the Defendants and their related entities. The Defendants do not admit any wrongdoing or liability and disagree with the allegations in the lawsuit.

The Federal Court still must decide whether to approve the settlement. (See Part E below)

C. Proposed Distribution of Settlement Funds

The settlement achieved in this litigation totals CDN\$2,095,350. The settlement funds, plus any accrued interest, less any deductions approved by the Federal Court, will be distributed to eligible Settlement Class members in a manner to be approved by the Federal Court.

Direct Payments

As part of the settlement approval hearing, the Federal Court will be asked to approve a protocol for the distribution of the settlement funds, plus interest and less the deductions set out above. See the proposed distribution protocol online at www.siskinds.com/XXX.

The distribution protocol proposes the following qualifications for payments:

- the Settlement Class member must be disclosed in the Defendants' sales data (provided in accordance with terms of the Settlement Agreement) as having purchased Caustic Soda directly from the Defendants between October 1, 2015 and February 29, 2020. Class Counsel consider this period to be the stronger liability case and therefore proposes only to compensate purchases during this period (as opposed to the full class period of October 1, 2015 to [date of consent certification order]). The Defendants deny any liability, including during this shorter period;
- subject to further directions of the Federal Court, the Settlement Class member's relevant purchases of caustic soda between October 1, 2015 and February 29, 2020 must equal at least CDN\$1,000,000; and
- the Settlement Class member must file a valid and timely Claim Form.

If the Federal Court approves the *cy près* payments (see below) and payment of Class Counsel fees and disbursements (see below), approximately CDN\$XX will be available for direct payments to qualifying Settlement Class members. Direct payments will be made to qualifying Settlement Class members *pro rata* (proportionally) based on the value of the eligible Settlement Class member's relevant purchases as against the total value of all eligible Settlement Class members' relevant purchases.

The compensation amount payable to individual Settlement Class members cannot be reliably estimated at this time because this will depend on the number of qualifying Settlement Class members, the number of Settlement Class members who file a claim, and the value of their claims. This Notice of Hearing is being sent to XX direct purchaser customers of the Defendants, but not all these customers will be eligible for payment or file a claim.

Only persons eligible to claim will be sent a further notice advising of the process and deadline for filing a claim.

Cy Près (Charitable) Payment

Recognizing that not all Settlement Class members are eligible to submit a claim and receive payment, the proposed distribution protocol provides that a *cy près* distribution in the amount of CDN\$25,000 will be made to each of GlobalMedic and Food Banks Canada.

GlobalMedic is a charitable organization that provides humanitarian aid to people affected by poverty, disaster and/or conflict. The *cy près* funds will be used to fund its "soap revolution" program. This program provides the most basic hygiene item – soap – to food banks and shelter partners. They can distribute bars of soap for a fraction of their retail price. Soap is made using caustic soda.

Food Banks Canada is a charitable organization that supports a network of food banks and community organizations across the country. The *cy près* funds will be used to purchase products containing caustic soda, such as soaps and cleaning supplies.

D. Proposed Payment of Fees and Disbursements

At the settlement approval, hearing, Class Counsel will ask the Court to approve the following deductions from the settlement funds:

- CDN\$XX in outstanding disbursements, plus applicable taxes in the amount of CDN\$XX. The largest disbursement relates to expert fees for the plaintiff's certification expert;
- Class Counsel fees of 20% of the settlement amounts, totaling CDN\$419,070.00, plus applicable taxes in the amount of CDN\$54,479.10; and
- any out-of-pocket expenses incurred by Class Counsel in administering the settlements, including the cost of notice and the cost of issuing payments, estimated at CDN\$6,000. There will be no fees associated with the distribution because Class Counsel proposes to self-administer the distribution to save costs.

E. Settlement Approval Hearing and Objecting to the Settlements

The settlement, distribution protocol and Class Counsel fees remain subject to approval by the Federal Court. The application for approval of the settlement will be heard by the Federal Court on April 22, 2026, at 10:00 AM, by videoconference. At this hearing, the Federal Court will determine whether the settlement is fair, reasonable, and in the best interests of the Settlement Class. The Federal Court will also be asked to determine whether the proposed distribution protocol is fair, reasonable, and in the best interests of the Settlement Class.

Settlement Class members who do not oppose the settlement, the proposed distribution protocol, and/or Class Counsel fees are not required to appear at the settlement approval hearing or take

any other action at this time. Settlement Class members who elect to seek the advice of their own lawyers do so at their own expense.

Objections

At the settlement approval hearing, the Federal Court will consider any objections by individual Settlement Class members to the settlement, the proposed distribution protocol, and/or Class Counsel fees. If you opt out by **XX**, 2025, you may be able to bring your own lawsuit against the defendants, but you will not be entitled to participate in the settlement.

All Settlement Class members will be bound by the terms of the settlement, unless they opt out of this class action. This is your only chance to opt out of the class action and bring your own, separate claim.

If you exclude yourself from the settlement, you may not object to the settlement. This is because the settlement no longer affects you.

If you wish to remain a Settlement Class member, you do not need to hire your own lawyer because Class Counsel is working on your behalf. You do not have to pay Class Counsel out-of-pocket. Class Counsel will be asking that the Federal Court approve legal fees up to 20% of the settlement funds (CDN\$419,070.00), plus disbursements and taxes. Any approved legal fees and disbursements will be paid out of the settlement fund.

If you exclude yourself from the Settlement Class (including because you wish to pursue our own case separate from the class action), these lawyers will no longer represent you. You may elect to hire your own lawyer if you wish to pursue your own lawsuit against the defendants.

H. More Information

This notice is given to you on the basis that you may be a Settlement Class member whose rights could be affected by the class action. This notice should not be understood as an expression of any opinion of the Federal Court as to the merits of any claim or defences asserted in the class action. Its sole purpose is to inform you of the class action so that you may decide what steps to take in relation to it.
