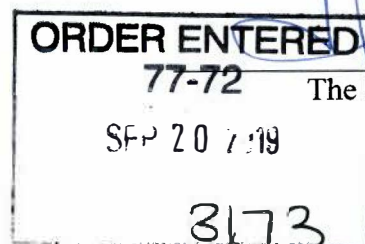
ORDER

THIS MOTION, made by the Plaintiffs and Siskinds LLP (“**Siskinds**”) for an Order: (i) approving the retainer agreements between each of the Plaintiffs and Siskinds; (ii) approving Class Counsel Fees; (iii) approving an interim payment of the Funding Commission; and (iv) approving the payment of an honorarium to each of the Plaintiffs, was heard this day at 80 Dundas Street, London, Ontario.

ON READING the materials filed and on hearing the submissions of Siskinds.

1. **THIS COURT ORDERS** that, except as otherwise stated, this Order incorporates and adopts the definitions set out in the Settlement Agreement reached between the Plaintiffs and the Defendants on June 7, 2019.

2. **THIS COURT ORDERS** that, pursuant to section 32 of the *Class Proceedings Act, 1992*, SO 1992, c 6 ("**CPA**"), the revised retainer agreement between Peter Rooney and Siskinds dated January 2012 is hereby approved.
3. **THIS COURT ORDERS** that, pursuant to section 32 of the *CPA*, the revised retainer agreement between Archie Leach and Siskinds dated January 2012 is hereby approved.
4. **THIS COURT ORDERS** that, pursuant to section 33 of the *CPA*, Class Counsel Fees in the all-inclusive amount of \$2,321,197.99 are hereby approved and are payable on or after the Implementation Date, comprising:
 - (a) \$1,787,500.00 for legal fees;
 - (b) \$232,375.00 for taxes on legal fees;
 - (c) \$266,798.55 for disbursements; and
 - (d) \$34,524.44 for taxes on disbursements.
5. **THIS COURT ORDERS** that an interim payment of the Funding Commission, payable pursuant to the Funding Agreement approved by Order of this Honourable Court dated November 21, 2013, in the amount of \$248,636.88 is hereby approved and is payable on or after the Implementation Date.
6. **THIS COURT ORDERS** that an honorarium of \$10,000.00 to each of Peter Rooney and Archie Leach from the Settlement Amount is hereby approved and is payable on or after the Implementation Date.
