**~~PROPOSED~~ ORDER CONCERNING  
DISTRIBUTION OF NET SETTLEMENT FUND TO  
AUTHORIZED CLAIMANTS AND RELATED MATTERS**

WHEREAS U.S. Lead Plaintiffs, on behalf of the U.S. Class, have moved this Court, pursuant to Rule 23 of the Federal Rules of Civil Procedure, for an Order: (i) authorizing distribution of the Net Settlement Fund to eligible Authorized Claimants pursuant to the Stipulation and Settlement Agreement (the "Stipulation"), dated as of November 6, 2008; (ii) authorizing the Claims Administrator to deem 84 late-filed but otherwise eligible claims that were submitted after the March 19, 2009 deadline for filing Proof of Claim forms timely; (iii) authorizing payment of fees charged and expenses incurred by the Claims Administrator, Strategic Claims Services, LLC ("SCS"), in the amount of \$145,951.65, to be paid from the Net Settlement Fund; and (iv) permitting the destruction of Proof of Claim forms and all related paper documents within one year of distribution of the Net Settlement Fund, and destruction of all electronic copies of the same within three years of the distribution, and good cause appearing therefor, the Court hereby ORDERS as follows:

1. The motion is granted in its entirety.
2. The Net Settlement Fund shall be distributed forthwith to eligible Authorized Claimants, consistent with the Stipulation and Plan of Allocation of the Net Settlement Fund, and as listed in Exhibit B-1 of the Affidavit of Paul Mulholland, CPA, CVA Concerning

Administrative Procedures Performed to Process Claims and the Results Thereof, dated October 26, 2010 (the "Mulholland Aff.").

3. Otherwise eligible claims that were submitted after the March 19, 2009 filing deadline, listed in Exhibit B-2 of the Mulholland Aff., are hereby deemed timely and shall be included in the Settlement and distribution.


4. SCS shall be paid fees and expenses from the Gross Settlement Fund in the total amount of \$145,951.65.

5. One year after distribution of the Net Settlement Fund, SCS may destroy any paper copies of the Proof of Claim forms and all related paper documentation, and three years after distribution of the Net Settlement Fund, SCS may destroy any electronic copies of the same.

IT IS SO ORDERED.
