## **Notable Work and Decisions**

## Obstetrical Malpractice - NST - Hypoxia - Brain Damage, Developmental Delay and Cognitive Deficits

Resolved case alleging failure to respond to non-reassuring fetal heart recordings. Standard of care failure alleged against obstetricians and nurses. Standard of care failures causing in prolonged hypoxia, brain damage, developmental delay and cognitive deficits.

## Emergency Physician Malpractice – Neurological Deficits – Spinal Cord Damage and Paralysis

Resolved alleging emergency physicians' failures to examine for neurological deficits and order MRI, and subsequent failure to respond to progressive neurological deficits. Standard of care failures causing spinal cord compression, irreversible neurological deficits and paraplegia.

## General Surgical and Medical Malpractice - Failure to anti-coagulate - Stroke - Paralysis

Resolved case alleging failure to anti-coagulate an inpatient for clot prophylaxis causing stroke and quadriplegia.

#### **Chiropractic Malpractice**

Trial award of damages for back pain caused by chiropractic failures to adequately discuss the potential risks and alternatives of the proposed treatment, and failure to perform a proper examination, which led to an exacerbation of the underlying lumbar disc herniation.

#### Deboer v. Dr. D.M. Kolyn et al., 2016 ONSC 7108

Trial decision awarding damages to the plaintiff for breaches of the standard of care by a radiologist and a general surgeon which delayed the diagnosis of the Plaintiff's breast cancer. The Trial Judge held that but for the Defendants' negligence, the Plaintiff would not be suffering from cancer metastases in her bones and would not die prematurely from this disease.

## Boyd et al. v. Edington et al., 2014 ONSC 1130 (SCJ)

Trial decision awarding damages to the plaintiff for an emergency room physician's failure to recognize the possibility of a stroke, his decision to reduce blood pressure, and his failure to consult with a specialist after his initial assessment. The Trial Judge held that but for these failures the plaintiff would not have suffered a debilitating stroke.

## Medical Malpractice Trial Award for Failure to Obtain Informed Consent and Injuries from Delayed Diagnosis of Ureteric Injury

Damages awarded to plaintiff for failure to obtain informed consent to laparoscopic hysterectomy procedure and injuries from delay in diagnosing ureteric injury sustained during the procedure at the Ontario Superior Court of Justice.

## Medical Malpractice Trial Motion Regarding Number of Experts

Successfully opposed trial motion of the defence to request leave to call more than three expert witnesses in complex case relating to the recognition and management of neurological symptoms in the plaintiff who was suffering a stroke which ultimately resulted in quadriplegia.

#### **Obstetrical Malpractice – Pediatric Malpractice – Brain Tumour – Delayed Diagnosis**

Represented a child who suffered a complex brain injury following a delay in diagnosis and treatment of a brain tumour.

#### **Obstetrical Malpractice – Oxytocin – Bradycardia – Cerebral Palsy**

Resolved case for a child with cerebral palsy due to prolonged oxygen deprivation causing hypoxic brain injury. Standard of care issues related to inappropriate commencement, and continuation, of intravenous oxytocin coupled with failures to recognize and manage prolonged bradycardia in the second stage of labour.
