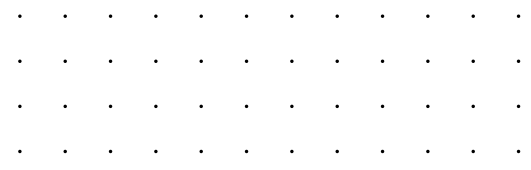
## About
